Proof of vaccine for long-term care facilities


Visitor policy for long-term care and all other health-care settings in B.C. is being updated. Starting October 12, 2021, visitors to long-term care and assisted-living facilities will need to show their vaccine card for proof of full immunization. Starting October 26, 2021, visitors to acute-care settings will also need to show they are fully vaccinated.

Northern Health residents can now book a COVID-19 test online!


People in the North are currently directed to their primary care provider or to the NH Virtual Primary and Community Care Clinic (VPCCC) to access a COVID-19 assessment and laboratory requisition. In the last month, COVID-19 cases have increased across the region, putting significant pressure on health care to respond.

To address this concern, starting October 4, 2021, symptomatic Northerners that require a COVID-19 test will be able to access an online



NH COVID-19 Testing Request Form. This form will initiate the process for individuals to access a test at their preferred testing site. People can still continue to call the NH Virtual Clinic or contact their primary care provider for a COVID-19 assessment and test.

The website for the <u>COVID-19 test booking form</u> is now live, and will be shared with the public on the <u>Northern Health website</u> and social media channels.



Proof of vaccination and the BC Vaccine Card

The BC Vaccine Card is now the only acceptable proof of vaccination for British Columbians to enjoy certain businesses and recreational events safely.

For Northern Health, Environmental Public Health Team responds to incoming complaints related to the Provincial Health Officer (PHO) orders (face coverings and vaccine status, for instance). The Environmental Public Health Team will reach out to non-compliant facilities to provide education, and then follow progressive enforcement processes that could include ticketing and potential closure orders.

- Currently in ICU level care in hospital: 16
- Deaths in the NH region since the beginning of the pandemic: 176

OVERDOSE PREVENTION & RESPONSE

Illicit drug toxicity deaths for July 2021 now available (BC Coroners Report – released September 29)

Attached are the most recent Coroner Reports for Illicit Drug Toxicity Deaths that contain data until the end of July 2021.

Summary:

- July 2021 (N=184) was the second largest number of suspected deaths ever recorded in a month. June 2020 had more deaths. (N=186).
- The 1,204 suspected illicit drug toxicity deaths between January and July 2021 are the highest ever recorded in the first seven months of a calendar year and represent a 28% increase over the number of deaths recorded between January and July 2020 (941).
- In January to July 2021, VCH had the highest rate of illicit drug toxicity deaths in the
 province with a rate of 47 deaths per 100,000 individuals. Northern Health had the second
 highest rate of illicit drug toxicity deaths in the province with a rate of 46 deaths per
 100,000 individuals

Northern Health Summary

- NH saw 12 illicit drug toxicity deaths in July 2021 (35 deaths per 100,000 individuals)
 - NW has seen 23 illicit drug toxicity deaths in 2021 for a rate of 51.9 deaths per 100,000 individuals, which is the third highest rate in the Province
 - There were 7 deaths in July
 - NI has seen 36 illicit drug toxicity deaths in 2021 for a rate of 41.8 deaths per 100,000 individuals, which is the seventh highest rate in the Province.

- There were 3 deaths in July
- NE has seen 18 illicit drug toxicity deaths in 2021 for a rate of 46.9 deaths per 100,000 individuals, which is the sixth highest rate in the Province.
 - There were 2 deaths in July

Overdose alert for Prince George

There has been an increase in overdose events in Prince George. The reported substance is green and chalky. This substance is highly toxic, causes heavy and prolonged sedation, and requires more naloxone to reverse. Overdoses are happening when the substance is smoked and injected.
