



Northern Health New COVID Cases by Reported Date






Number of COVID-19 Cases Per Week Last Three Months

Northern Health COVID-19 Average Daily Rate per 100,000 for October 2021



Northern Health COVID19 Cases that were Hospitalized and in ICU by Immunization Status, All Age Group, All LHA(s)




NH Enforcement Approach

- NH's Environmental Public Health (EPH) sits on a Provincial working group, including RCMP, WSBC, Liquor the Ministry and Bylaw. The group is developing roles, responsibilities and communications.
- EPH is receiving a fair number of complaints of non-compliance.
 We follow up with all, following a progressive enforcement process.
 This includes clarification, education, expectation, warning, and enforcement, (which could include tickets, compliance orders, and closure orders).
- We will be prioritizing enforcement for egregious non-compliance or concern for significant community impact.
- To date, most are in compliance, or become compliant after consultation calls.

Includes Site Clinic Data and Community Clinic Estimates (Survey or Anecdotal) As reported by industry March – October 8, 2021









Mandatory Vaccination Reporting

- Major projects currently collecting information per mandatory vaccination reporting letters issued from MHOs.
- Mines and Other not subject to this level of reporting. Our data relies only on number of doses provided and number of workforce. It does not provide accurate site information because of issues of attrition.

Program Participants

- HRD is working with Petronas to bring them onboard the immunization program. Their clinic could initially serve their workers, but may be opened to support other operators in the area and community.
- September 24th NH partnered with Energy Safety Canada to provide a 1.5 hour webinar to operators in the region, specifically targeting the NE to raise awareness of public health requirements.
 - 92 participants on the call
 - Numerous inquiries following the session specific to testing and controls.




