The organization is planning a number of activities to achieve an ongoing annual source of funding for its marketing activities. These include: • Requesting the CRD, 100 Mile District and NDTI to amend the agreement with the South Cariboo Community Enhancement Foundation to allow for an annual allotment of funding from the interest generated by the endowment to cover marketing expenses • Soliciting sponsorships from businesses in the South Cariboo • Developing partnerships for in kind donation of

marketing expenses • Securing additional endowments and funding which will allow for an marketing allocation to the SCCEF Our research has indicated organizations like ourselves fund marketing and other costs as a percentage of the endowment fund and/or grants given.

3. What are your organization's specific goals and objectives for this year? How do they differ from previous years?

The mission of the SCCEF is to support, promote, advance and encourage all community members of the South Cariboo. This is accomplished in the following ways: • Education by establishing scholarship funds and providing funds for specific education endeavours • Community Support by providing programs that directly benefit the needy and assist in alleviating human suffering and poverty • Sports by encouraging amateur sports and recreation in our community • Arts and Culture activities by supporting all forms of art and culture • Preservation by promoting the preservation of lands and buildings or historical or environmental value as well as protection of the environment through hands-on projects as well as through courses and seminars directed at educating the public.

4. Who does your organization serve?

The South Cariboo Community Enhancement Foundation serves children, youth, families and seniors living in the South Cariboo. Annually the endowment now provides approximately \$25,000 in funding. SCCEF follows a rigorous application and review process to ensure that funding is granted to projects meeting the objectives of the Foundation as outlines in its Constitution and Bylaws. The SCCEF also looks to partner with other granting agencies to leverage and increase grant funding to our community. The past year has been especially challenging for non profit organizations in our community due to Covid 19 impacting negatively on regular fundraising activities as well as the additional financial resource necessary to meet Covid 19 regulations. Grants from SCCEF are assisting organizations to stay operational during this time. Since 2018, the interest generated from the endowment fund has allowed SCCEF to provide grants to the following organizations: • Special Olympics \$2500 - Ski Program • 100 Mile Community Club \$8500 purchase and installation of industrial dishwasher • Cariboo Chilcotin Partners for Literacy \$2500 -Kindergym • Timothy Lake Community Association \$5000 - year 1 funding of 3-year project for a boat launch and picnic area for the public and emergency services • 100 Mile House White Cane Association -\$4500 to support annual services. • Cariboo Pioneer Centre \$2500 - to support programming. An additional \$2500 was provided by United Way to support COVID 19 projects • Stemete7uy'i Friendship Centre (2019 and 2020) - \$2,500 for First Nations programming and \$5000 to fund operational and COVID 19 costs • Lone Butte Historical Association - \$2500 to support operational and COVID 19 costs. • Cariboo Family Enrichment Centre - Gender Equality programming. \$5,000 An additional \$5,000 was provided by Community Foundations of Canada with whom SCCEF partnered as a matching grantor The South Cariboo Community Enhancement Foundation has partnered with the Prince George Community Foundation, United Way Thompson Nicola and Community Foundations of Canada to bring \$15,500 funding to the South Cariboo. In addition, in 2018 we also received \$5,000 Federal funding which was awarded by us to: • Cariboo Chilcotin Partners for Literacy \$2500 - Story Walk Program • Cariboo Family Enrichment Centre \$2,500 - Relate Parenting Program (for parents of teenagers)

1. Brief Description of Proposed Use of Grant Being Applied For:

This project requests funding of \$1500 to cover marketing costs related to the operation of the South Cariboo Community Enhancement Foundation. The seven members of Board of the Foundation annually give over 340 hours of their time to support the work of the Foundation. To establish a permanent presence in the South Cariboo, promote granting opportunities, develop partnerships and attract new endowments, and funding the SCCEF needs to expend marketing resources including: • Website subscription and ongoing updating and maintenance • Advertisements • Marketing Material • Promotional events The original agreement between the NDIT, DHM and CRD requires endowment returns to be limited to grants only, and we have no means to cover these marketing costs. The grant for assistance will allow the SCCEF to develop additional funding opportunities for organizations in the South Cariboo to contribute to the health and well being of our residents.

2. How do you know there is a need for this service/project in our community?

The South Cariboo requires an active and robust Foundation to help these organizations meet the needs of vulnerable individuals in the South Cariboo as well as to enhance recreational, cultural and community events. The need for the South Cariboo Community Enhancement Foundation is evident by the number of organizations that have applied for funding and those that also apply for funding through the Grants for Assistance program. All community and non profit organizations have also suffered greatly from the COVID 19 epidemic which has reduced and eliminated many of their fundraising events.

These reports show the impact that the SCCEF grants are having on the health and well being of South Cariboo residents. Most of the projects funded by the SCCEF continue long after the grant and have lasting positive impacts on the South Cariboo. We will know that we have been successful when the Foundation is able to increase the annual grant funding provided to the South Cariboo.
