COVID-19

Northern Health celebrates over 82 per cent COVID-19 immunization

In Northern BC, over 82% of the population aged 12 and over are immunized with at least one dose of the COVID-19 vaccine.

This success is due to the tireless efforts of the Northern Health staff and vaccine planning teams, the First Nations Health Authority, our community partners and stakeholders, and Northern BC residents who recognize the importance of protecting themselves, their families and their communities, so that we can get through this pandemic. Thank you to



everyone who has helped us achieve this milestone!

Vaccination clinics are still running across the North, including opportunities for 5-11 year olds to receive their first dose. Visit the NH website for clinic details in your community.

COVID-19 immunization plan

Pediatric dose

The Pfizer COVID-19 vaccine is now available for children 5 to 11. This vaccine uses a lower dose (10 micrograms), at one-third of the dose formulated for older children and adults, which will provide effective protection tailored to children's immune systems. The National Advisory Committee on Immunization (NACI) advises that children receive a two-dose series of the vaccine with an interval of eight weeks or more between the first and second dose.

Third dose

The third dose of the COVID-19 vaccination is for some people who are moderately to severely immunocompromised. People who need a third dose <u>will be contacted</u> by the provincial <u>Get Vaccinated</u> system.

Third dose immunizations will be by appointment only, they are not available for walk-ins.

Booster dose

The booster dose is an additional non-urgent, non-compulsory vaccine that gets immunity back up to a desirable level of protection for an

extended period of time. It will be available starting in January 2022.

To book a booster dose, please ensure you're registered in the <u>Get Vaccinated</u> system. If you have difficulty accessing online booking, please call 1-833-838-2323.

Booster dose shots will be by appointment only, they are not available for walk-ins.



OVERDOSE PREVENTION & RESPONSE

Overdose alert for the Quesnel area

Due to an increase in overdose events in the community of Quesnel, Northern Health and the First Nations Health Authority issued a joint overdose alert on December 2, 2021.

Despite this being a community specific alert, please share broadly, as we know that substances move throughout our region and may present in other communities:

- The reported substance is light purple/blue in powder/pebbles, and when broken apart it turns pink. It is sold as down.
- It is highly toxic, causes heavy and prolonged sedation and requires more naloxone to reverse.
- Overdoses are occurring when the substance is injected.
- One of the first signs of overdose is choking, gurgling, or snoring sounds

Key Messaging

- Don't use alone, if possible use an OPS
- If you have to use alone use <u>Lifeguard</u> or <u>Be Safe</u> apps.







- Don't mix with other substances
- Carry and know how to use naloxone
- Call 911 or your local emergency number right away if someone overdoses.
