Target stands on rifle range need attention and with the price of wood skyrocketing it was discussed to take trees from clearing along the range and cut them to 2" thick slabs and use them for backing to hang targets

Discussion about having a womens day and a youth day for introduction to shooting both 22 rifle and trap

Work bees to do painting and general cleanup as well as any other projects we can find

Discussed turning the trap field 90 degrees so we are shooting into the mountain and not just into the bush

Discussed building a berm at the side of rifle butts to stop any projectiles from accidently coming toward trap field

Lenard Baronit to look into a cell booster to give us cell service in case of emergency

Discussed setting up a first aid station in the storage room and updating first aid kit

Much discussion about putting in a water system to make the bathroom in the clubhouse usable Temporary stairs into clubhouse need to be upgrade Discussion about putting skirting around the bottom of clubhouse

Dale Willis and Skylar have built target stand for rifle range as a school project for Skylar will do story in paper

Conclusions of discussions

Gerry Hay and Rob Jones are going to be doing the finishing work on the clubhouse both inside and outside Gerry Hay has offered to cut slabs off our trees to fix up the rifle target stands

Lenard Beronit has offered to come and paint inside of clubhouse when Gerry and Rob are finished

More discussion needed around water system for bathroom

More discussion and investigation needed on turning the trap
field

All in attendance agreed the the berm on rifle range and turning the trap field were safety upgrades and should be done
