BYLAW NO. 5364

Being a bylaw to amend Bylaw No. 1905, cited as "Lac La Hache Specified Area Sewer Management Bylaw No. 1905, 1986."

WHEREAS Bylaw No. 1905, 1986, as amended, provides for the regulation and management of the Sewer System of the Lac La Hache Sewer Specified Area within Electoral Area "G" of the Cariboo Regional District and for terms and conditions upon which sewer services may be provided and for a tariff of charges for such services;

AND WHEREAS it is deemed necessary to amend the annual user rates on current and future sewer connections;

NOW THEREFORE the Board of the Cariboo Regional District in open meeting assembled, enacts as follows:

1. AMENDMENT

That Schedule "B" of the Lac La Hache Specified Area Sewer Management Bylaw No. 1905, 1986 is hereby deleted in its entirety and Schedule "B" attached hereto is substituted therefor.
