Memorandum:

One of the goals identified in the Planning Services 2022 Business Plan is to review and update Board policies related to the Planning Services Department. Many policies are outdated and either no longer necessary or require substantial revision to align with current legislation, best practices, and current department procedures. Some policies were last revised in 1991. There are currently 36 policies related to the function of the Planning Services Department. Twelve policies have been identified for immediate rescindment, 13 for revision, and 19 require research to determine if they are meeting department needs. A summary table of policies recommended for rescindment is attached. As the year progresses and time permits, staff will bring forward review findings and recommendations for the remaining planning policies. This initial agenda item recommends rescindment of 12 policies as they are no longer relevant due to provincial legislative and procedural changes, or changes to the CRD operational context.
