#### Recommendation

That the Central Cariboo Joint Committee direct staff from the Cariboo Regional District and the City of Williams Lake to negotiate a fair value for service recreational agreement and sub-regional recreation budget amount for the Central Cariboo Joint Committee to consider for 2023 and beyond budget cycle.

#### **Purpose**

The purpose of this report is to bring the discussion back to the committee for further investigation into a negotiated agreement similar to the agreement in place with the Cariboo Regional District and the City of Quesnel for like minded recreational use spaces and services.

The report is created for another opportunity that could enhance the recreation opportunities available to both the residents of the Cariboo Regional District and the City of Williams Lake. This can be achieved by enhanced services to the parks, trails, and sport areas to mutually benefit all residents' recreational pursuits in specific recreation spaces, within the boundaries of the City of Williams Lake. The discussions between the two parties ceased after February 2021, due to other emergent priorities determined by each party.

This report is being brought to Joint Committee as the City was recently asked by the Regional District to consider participating in the proposed regional trials and parks service. The City is seeking clarification on how these different shared service proposals fit together.

### **Background / Discussion**

In and around the City of Williams Lake there are specific recreation opportunities within current parks, trails, and sport areas for many residents to utilize. These areas are utilized frequently by residents of both the City of Williams Lake and the Cariboo Regional District. Like the agreement between the Cariboo Regional District and the City of Quesnel, the City of Williams Lake desires a report developed by staff and between staff to provide an option for the Central Cariboo Joint Committee's future budget consideration.

#### **History:**

The City of Williams Lake Community Services Committee met back in March 2020 to consider options for partnering with the Cariboo Regional District for enhanced trail, park, and other recreation spaces.

To move this type of partnership forward, a report to Council was done and presented. At the March 24, 2020, Council meeting a resolution (Res 91/20) was carried and the staff began researching further information. Res #91/20 was brought forward during the September 22, 2020, meeting of Council, leading to another direction for staff. (Res #289/20). There was some discussion at the Central Cariboo Joint Committee on November 27, 2020, where this item was referred to the Central Cariboo Rural Directors Meeting scheduled for January 27, 2021.

At the January 27, 2021, Central Cariboo Rural Directors Caucus Meeting this report was discussed City representatives available to answer questions. The Central Cariboo Rural Caucus Members, at the January  $27^{th}$  meeting, referred their final discussion and decision to the Central Cariboo Directors Caucus Meeting February 24, 2021, was held. Resolution (CCR.2021 – 2 – 4) on February 24, 2021, was carried by consensus at the Central Cariboo Rural Directors Caucus Meeting. At the April 28, 2021 Central Cariboo Joint Committee meeting, the Committee received for information the decision of the rural directors.

The Cariboo Regional District has a Memorandum of Understanding with the City of Quesnel to reimburse that municipality for costs associated with recreation assets that serve the larger region. The specific parks in Quesnel in the MOU are:

- 1. The River Trails,
- 2. West Fraser Timber Park (ball fields and courts),
- 3. Lebourdais Park (ball field and water park).

The City of Williams Lake is looking for consideration to have a similar agreement within the Sub-Regional Recreation Budget through the Central Cariboo Joint Committee.

It would be beneficial to have staff review these areas listed below to see if they can be considered recreational assets for the region, and to work together to bring back an option that would be considered by this Joint Committee to continue maintaining these excellent recreation options in our areas. The following spaces are what the City of Williams Lake would like considered in a cost sharing agreement:

### **Stampede Grounds**

- 2022 Budget \$39,897
- 2021 Actual \$19,067.65

#### **Boitanio Park**

2022 Budget \$145,1492021 Actuals \$143,021.66

#### **Kiwanis Park**
