



## CARIBOO REGIONAL DISTRICT

### BYLAW NO. 5348

A bylaw to expand the boundaries of the Alexis Creek Water System service to include the Central Alexis Creek Water System service.

**WHEREAS** pursuant to the *Local Government Act*, a Regional Board may provide for changes to the boundaries of a service area, including merging two or more service areas, with the consent of at least 2/3rds of the participants; and

**WHEREAS** the Regional Board of the Cariboo Regional District established the Alexis Creek Water System Specified Area by Bylaw No. 1433, 1982 for the provision of a water service in a portion of Electoral Area K; and

**WHEREAS** the Regional Board of the Cariboo Regional District established the Central Alexis Creek Water System Service Area by Bylaw No. 4340, 2008, as amended, for the provision of a water service in a portion of Electoral Area K; and

**WHEREAS** the Regional Board of the Cariboo Regional District wishes to expand the boundaries of the Alexis Creek Water System Specified Area to include the Central Alexis Creek Water System Specified Area; and

**WHEREAS** the Regional Board of the Cariboo Regional District wishes to name the service area the “Alexis Creek Water Service Area”; and

**WHEREAS** the Director of Electoral Area K has consented in writing to the adoption of this bylaw;

**NOW THEREFORE** the Regional Board of the Cariboo Regional District in open meeting assembled enacts as follows:

#### TEXT AMENDMENTS

Alexis Creek Water System Specified Area Establishment By-law No. 1433 is hereby amended as follows:

- 1) Section 1 is hereby deleted and replaced with the following:

## SERVICE ESTABLISHMENT

The service areas established by Alexis Creek Water System Specified Area Establishment Bylaw No. 1433, 1982 and Central Alexis Creek Water System Service Establishment Bylaw No. 4340, 2008, as amended, are hereby merged and shall be known as the Alexis Creek Water Service Area.

The purpose of the Alexis Creek Water Service shall be to undertake and carry out or cause to be carried out and provide a water system in and for the said Alexis Creek Water Service Area and to do all things necessary in connection therewith.

2) Section 2 is hereby deleted and replaced with the following:

### COST RECOVERY

- a) The annual costs for the service shall be recovered by one or more of the following:
  1. parcel taxes imposed in accordance with Part 11: Division 3 of the *Local Government Act (Requisition and Tax Collection)*;
  2. fees and charges imposed under section 397 of the *Local Government Act (Imposition of fees and charges)*;
  3. revenues raised by other means authorized by the *Local Government Act* or another act; and/or
  4. revenues raised by way of agreement, enterprise, gift, grant or otherwise.
- b) The maximum amount of money that may be requisitioned in any one year for the service provided in Section 1 of this bylaw shall not exceed the greater of \$50,000 or an amount raised by applying a tax rate of \$12.50/\$1,000 to the net taxable value of land and improvements in the service area.

3) Section 3 is hereby deleted and replaced with the following:

### SERVICE BOUNDARIES AND PARTICIPANT

- a) The boundaries of the merged area are those shown on Schedule A, attached hereto and forming a part of this bylaw.
- b) The participant of the Alexis Creek Water Service is Electoral Area K.

4) Section 4 is hereby deleted and replaced with the following:

CITATION

This Bylaw shall be cited for all purposes as the “Alexis Creek Water Services Merge Bylaw No. 5348, 2021”.
