

The BCSPI member journey maps each organization's steps towards social procurement implementation. It begins with staff onboarding and access to resources and training before guiding members through a testing phase with pilot projects supported by expert coaching, examples, and customizable templates. Once social procurement has been sufficiently tested, it can be included in a member's organizational policy.

BCSPI provides additional support with policy templates and customized policy training to help integrate these new practices across the whole member organization. When the entire implementation phase is reached, members can access supplier engagement resources and impact measurement tools to ensure that the demand and supply side is fully connected and social value and impact outcomes are being measured and reported.
