



CARIBOO REGIONAL DISTRICT

BYLAW NO. 5398

A bylaw to expand the boundaries of the Cariboo Regional District Central Cariboo and Chilcotin Economic Development Service Area to include the South Cariboo Economic Development Service Area and the North Cariboo Economic Development Extended Service Area.

WHEREAS pursuant to the Local Government Act, a Regional Board may provide for changes to the boundaries of a service area, including merging two or more service areas, with the consent of at least 2/3rds of the participants; and

WHEREAS a service has been established by the Cariboo Regional District by Bylaw No. 2586, cited as "North Cariboo Economic Development Grant-in-Aid Extended Service Establishment Bylaw No. 2586, 1992";

AND WHEREAS a service has been established by the Cariboo Regional District by Bylaw No. 3878, cited as "Cariboo Regional District South Cariboo Economic Development Service Establishment Bylaw No. 3878, 2004" as amended;

AND WHEREAS a service has been established by the Cariboo Regional District by Bylaw No. 5244, cited as "Cariboo Regional District Central Cariboo and Chilcotin Economic Development Services Merge Bylaw No. 5244, 2019";

AND WHEREAS the Cariboo Regional District Board wishes to expand the boundaries of the Cariboo Regional District Central Cariboo and Chilcotin Economic Development Service to include the South Cariboo Economic Development Service Area and the North Cariboo Economic Development Extended Service Area;

AND WHEREAS the Regional Board of the Cariboo Regional District wishes to name the service area the "Economic Development Service Area";

AND WHEREAS consent has been received from at least two-thirds of the participants to merge the service areas accordingly;

NOW THEREFORE the Cariboo Regional District Board, in open meeting assembled, enacts as follows:

TEXT AMENDMENTS

Cariboo Regional District Central Cariboo and Chilcotin Economic Development Services Merge Bylaw No. 5244, 2019 is hereby amended as follows:

1. Section 1 is hereby deleted and replaced with the following:

CITATION

This bylaw may be cited for all purposes as the "Cariboo Regional District Economic Development Services Merge Bylaw No. 5398, 2022".

2. Section 2 is hereby deleted and replaced with the following:

SERVICE DESCRIPTION

The purpose of the Economic Development Service created under this bylaw is to provide support for projects and activities that improve the local economic situation including but not limited to work in important sectors such as tourism, agriculture, natural resource development and the retention and attraction of businesses and residents, within the boundaries of the merged service area to be known as the Economic Development Service Area.

3. Section 3 is hereby deleted and replaced with the following:

SERVICE AREA AND PARTICIPANTS

- a) The merged Service Area is all the Electoral Areas within the Cariboo Regional District and shall be known as the Economic Development Service Area.
- b) The participants in the merged Economic Development Service are all Electoral Areas.
