100 Mile and District Outriders – Equestrian Grounds Use and Occupancy Agreement Renewal

Memorandum:

The Cariboo Regional District has a five-year Use and Occupancy agreement (January 2018-December 2022) with the 100 Mile and District Outriders Club for the equestrian grounds adjacent to the South Cariboo Recreation Centre.

The agreement will expire at the end of 2022 and is brought forward for consideration of renewal.

Staff has been in contact with the group and a renewal of the agreement with the current terms and conditions is expected.

Under the agreement, the Outriders Club manages the equestrian grounds and ensures appropriate and safe community access to the areas.

All revenues from the grounds are retained by the club to assist with operating costs and capital improvements.

Financial Implications:

Under the agreement, the Outriders pay \$220 per year for the use and occupancy of the equestrian grounds. Occasionally, grant funding is provided to the group upon request for capital projects through the grant for assistance process.
