Blessings Grave and Stanley Cemetery Outhouse Maintenance Contribution Agreement

Memorandum:

For the North Cariboo Director's consideration, on January 1, 2012, the Cariboo Regional District (CRD) entered a contribution agreement with the Friends of Barkerville Cariboo Goldfields Historical Society (FOB) to maintain the sites and outhouses and carry appropriate public liability insurance for both the Blessings Grave Historic Site and Stanley Cemetery for \$1,250 annually. FOB declined to renew the agreement for January 1, 2021, due to capacity issues.

This spring, Barkerville Heritage Trust acknowledged the importance of the sites and expressed interest in maintaining them. They suggested an annual fee of \$4,800. Staff at Cottonwood house started maintaining the sites in the spring of 2022 in good faith the Trust would receive a financial contribution similar to the FOB society for the work.

The Cariboo Regional District participated in the original installation of these outhouses in a region-wide wheelchair accessible wilderness trail initiative and therefore holds an ongoing obligation to support or remove them.
