This election cycle was challenging in terms of finding staff to work the election, much as is the case in all sectors of the job force in today's labour environment. Consideration will be given in the next election cycle to advertising for election workers; acknowledging that this practice has both positive and negative implications. In addition, some of the more remote polling stations may be reviewed in terms of their practicality now that mail ballot voting is available to all electors. The Nazko station, for example, cost the CRD a significant amount to run, served only 11 voters, and was difficult to staff.

It was suggested that the CRD share its Notice of Election by Voting with the school districts for posting within the schools that will serve as polling stations, and staff intend to act on this for the next election cycle to help get election information out to local communities. Conversation has also taken place in regard to sending the Notice directly to First Nations Councils in the areas that will see a CRD election take place. Canada Post community mailboxes were also suggested as a potential spot that the CRD could put election information posters.

This election cycle, we looked at combining polling stations with member municipalities which did not end up being viewed as a benefit to the voting public, due to logistics and the many inconsistencies in voting processes and dates for advance polls.
