## **Short Summary:**

Disclosure of Contract - Director de Vries

### **Voting:**

#### Memorandum:

The *Community Charter* requires that council members (applicable to board members through section 787.1 of the LGA) disclose any contracts they have with the local government, as follows:

#### Disclosure of contracts with council members and former council members

**107. (1)** If a municipality enters into a contract in which (a) a council member, or (b) a person who was a council member at any time during the previous 6 months, has a direct or indirect pecuniary interest, this must be reported as soon as reasonably practicable at a council meeting that is open to the public.

(2) In addition to the obligation under section 100 [disclosure of conflict], a council member or former council member must advise the corporate officer, as soon as reasonably practicable, of any contracts that must be reported under subsection (1) in relation to that person. (SUB) May 29/14 (3) A person who contravenes subsection (2) is disqualified from holding office as described in section 108.1 [disqualification for contravening conflict rules] unless the contravention was done inadvertently or because of an error in judgment made in good faith.

In accordance with the above, and in consultation with Director de Vries, this item is to notify the Board that Director de Vries holds a contract with the Cariboo Regional District for snow removal and sanding at the Interlakes Volunteer Fire Department Fire Hall under the company name Bridge Lake Property Services.

This item is included at late publishing as the information was not received in time for the regular agenda deadline, and to meet the requirement above to report as soon as reasonably practicable.
