1. 100 Mile & District Arts Council - \$188 from Electoral Area G, \$188 from Electoral Area H, \$188 from Electoral Area L, and \$186 from the District of 100 Mile House for a total of \$750
2. 100 Mile House Festival of the Arts - \$850 from Electoral Area G, \$300 from Electoral Area H, \$850 from Electoral Area L, and \$500 from the District of 100 Mile House for a total of \$2,500
3. 100 Mile House Flying Club - \$500 from Electoral Area G, \$200 from Electoral Area H, \$800 from Electoral Area L, and \$500 from the District of 100 Mile House for a total of \$2,000 (waive policy - late)
4. 100 Mile House Hot July Nights Car & Bike Show Society - \$750 from Electoral Area G, \$750 from Electoral Area L, and \$1,500 from the District of 100 Mile House for a total of \$3,000
5. 100 Mile Nordics Ski Society - \$500 from Electoral Area G, \$200 from Electoral Area H, \$800 from Electoral Area L, and \$500 from the District of 100 Mile House for a total of \$2,000 (waive policy - operational)
6. Creekside Seniors Society - \$750 from Electoral Area G, \$750 from Electoral Area L, and \$1,500 from the District of 100 Mile House for a total of \$3,000 (waive policy – late and incomplete)
7. Eclectica Community Choir - \$125 from Electoral Area G, \$125 from Electoral Area H, \$125 from Electoral Area L, and \$125 from the District of 100 Mile House for a total of \$500
8. Forest Grove & District Rod and Gun Club - \$1,800 from Electoral Area H

13. Lone Butte Horse Lake Community Association - \$3,000 from Electoral Area L
14. PSO Dry Grad Committee - \$500 from Electoral Area G, \$500 from Electoral Area H, \$500 from Electoral Area L, and \$500 from the District of 100 Mile House for a total of \$2,000 (waive policy - late and incomplete)
15. South Cariboo Chamber of Commerce - \$750 from Electoral Area G, \$750 from Electoral Area L, and \$1,500 from the District of 100 Mile House for a total of \$3,000 (waive policy – late and incomplete)
