Road maintenance is a huge short fall in our community. Poor road conditions are unsafe.Community centres are currently being not maintained for use. Where is there informationabout housing and accessibility of this?

I have reviewed a "hard copy" of the CRD's draft financial plan (cost \$16.00) as the digital version is much too small to read online. I compared my 2022 Property Tax line items to the hard copy but was unable to compare some of the items as they were missing: 1) Cariboo Chilcotin Hospital, 2) South Cariboo Highway Rescue, 3) A breakdown of the Regional Libraries was not provided nor, 4) was any information provided for BC Assessment and Municipal Finance Authority Charges. This makes it very hard to compare 2022 to the draft 2023 items. Also, I would appreciate receiving a breakdown for Area G Cariboo. After School Taxes this is the next highest charge.

Finally, on reviewing the last five years of Property Tax rates I've found that they have been steadily increasing. This greatly concerns me as my 2023 Property Assessment has increased 18% over 2022. The CRD will benefit from high Assessments, so I would strongly suggest that the individual line items' tax rates do not increase over 2022. If they do, it would seem that the CRD would be Double Dipping;

103 Mile is unincorporated. However it forms part of 100 mile house. On our street of Lakeside, lower portion, we are all on well water. We are also on septic systems and do not use any of100 mile house water or waste system services. We have no street lights, no sidewalks and since moving here, we have almost nil road maintenance. I had to call out the Ministry of Transportation to show the lady how bad our road was and if an accident happened due to my bike falling over because the holes and bumps are unavoidable , I would be holding the District liable for damages and injury as my bike is 800 lbs. I think that Dawson is pathetic and is a waste of our taxpaying dollars. I also understand due to their under bidding, this is why our roads are in the shape they are in.

I also find that we have no garbage pick up without paying and there is absolutely no recycle program that should be paramount in light of our environment. There should be free curbside pick up of recyclables once per week as there is in the lower mainland.

I noted that there were many surpluses from the forecasted budget to the actuals for 2022. In saying this, the surpluses should be applied to the home owners taxation rates or realign the budgets so they are a bit more accurate.

The tax rate in 103 mile is exurbanite and much higher than the lower mainland which doesn't make sense to me as we don't have the same level of amenities or level of service here. Overall, I am very concerned that the financial plan doesn't include any recycle program that I could see as part of a garbage collection program. To sum up, we have no street lights, no use of 100 miles water systems, no sidewalks, no curbside recycle program, no sidewalk, and I recall that Dawson came down our road 2ce this winter and in the spring/summer all residents of Lakeside and area are subject to wrecking their vehicles and motorcycles due to lack of preventative maintenance. Other than that the budget looks good for other services.

I enjoy the library because I can't always get to town plus I have access to computers and internet.

I reside 6kms in a forest and do not partake in any services other than the refuse dump and the occasional, sporadic, road maintenance, which is poor at best. Personally I have zero investment or interest in the majority of the services I have to pay for.
