



## **CARIBOO REGIONAL DISTRICT**

### **BYLAW NO. 5422**

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to authorize borrowing funds to upgrade the aquatic centre at the Quesnel and District Arts and Recreation Centre in the North Cariboo Recreation and Parks Service Area.

**WHEREAS** the Board of the Cariboo Regional District has established by Bylaw No. 3900, 2004, a service to provide public recreation facilities and parks to the North Cariboo Recreation and Parks Service Area; and

**WHEREAS** it is desirable to upgrade the aquatic centre which is within the Service Area to meet modern standards for safety and user expectations; and

**WHEREAS** the cost of the aquatic centre upgrade is estimated at thirty-five million dollars (\$35,000,000), which is the amount of debt created by this bylaw; and

**WHEREAS** the maximum term for which a debenture may be issued to secure the debt created by this bylaw is for a term not to exceed twenty-five (25) years; and

**WHEREAS** the authority to borrow under this bylaw expires five (5) years from the date on which this bylaw is adopted; and

**WHEREAS** the Board of the Cariboo Regional District has obtained the approval of electors in the Service Area by voting in accordance with Section 407(3)(a) of the *Local Government Act*;

**NOW THEREFORE** the Board of the Cariboo Regional District in open meeting assembled, enacts as follows:

1. The Regional Board is hereby empowered and authorized to undertake and carry out or cause to be carried out the provision of an upgrade to the aquatic centre at the Quesnel and District Arts and Recreation Centre in the North Cariboo

Recreation and Parks Service Area, as established by “Cariboo Regional District North Cariboo Recreation and Parks Service Establishment Bylaw No. 3900, 2004”, and to do all things necessary in connection therewith and without limiting the generality of the foregoing:

- a) To borrow upon the credit of the Regional District a sum not exceeding thirty-five million dollars (\$35,000,000);
  - b) To acquire all such real property, easements, rights-of-way, licenses, rights or authorities as may be requisite or desirable for or in connection with the provision of said aquatic centre upgrade.
2. The maximum term for which debentures may be issued to secure the debt created by this bylaw is twenty-five (25) years.
  3. This bylaw may be cited as the “North Cariboo Recreation and Parks Loan Authorization Bylaw No. 5422, 2023”.
