#### **Memorandum:**

This item was deferred for up to 60 days at the January 13, 2023, Board meeting, to allow the applicant time to follow up with Williams Lake First Nation (WLFN). The agent has submitted a letter to WLFN (attached). A response from WLFN is expected prior to the Board meeting and will be published on the agenda when received. Note the staff recommendation has been revised to include a recommended condition to the ALC that the outstanding concerns of the WLFN are resolved.

Staff note the Board has the option to reject the application. WLFN has summarized numerous concerns and reasons to recommend rejection based on actions and alleged legislative contraventions that have historically occurred on the property. The Board may wish to consider rejection of the proposal with the understanding that a future application, after resolving the outstanding concerns, would have greater likelihood of approval.
