



## CARIBOO REGIONAL DISTRICT

### BYLAW NO. 5421

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to amend the North Cariboo Recreation and Parks Service.

**WHEREAS**, a recreation and parks service has been established by the Cariboo Regional District Board by Bylaw No. 3900, cited as “Cariboo Regional District North Cariboo Recreation and Parks Service Establishment Bylaw No. 3900, 2004”;

**AND WHEREAS**, pursuant to the provisions of the *Local Government Act*, a Board may, by bylaw, authorize the revision of all or any of the bylaws of the regional district;

**AND WHEREAS** the Board has deemed it desirable, and in the best interest of good government to increase the requisition limit allowed in Bylaw No. 3900, 2004;

**AND WHEREAS** the Board of the Cariboo Regional District has obtained the approval of the service area electors by assent vote in accordance with Section 344 of the *Local Government Act*;

**NOW THEREFORE**, the Board of Directors of the Cariboo Regional District, duly assembled in an open meeting, enacts as follows:

1. CITATION

- a) This bylaw may be cited for all purposes as “North Cariboo Recreation and Parks Service Amendment Bylaw No. 5421, 2023”.

2. COST RECOVERY

Section 5 of Bylaw No. 3900 is hereby deleted in its entirety and replaced with the following:

- a) All costs associated with this service shall be recovered by way of:
- i. property value taxes imposed in accordance with Part 11, Division 3 of the *Local Government Act*;
  - ii. fees and charges imposed under section 397 of the *Local Government Act*;
  - iii. revenues raised by other means authorized by the *Local Government Act* or any other Act;
  - iv. revenues received by way of agreement, enterprise, gift, grant, or otherwise.
- b) The maximum requisition for this service shall not exceed the greater of \$9,000,000 or the product of \$2.8648 per \$1,000 of assessment on lands and improvements as prepared for hospital district purposes in all participating areas.
