Short Summary:

Cariboo Regional District 2023 First Quarter Financial Reports

Voting:

Memorandum:

The Financial Reports for the first quarter of 2023 are presented for the Board's review. The reports cover the January 1 – March 31, 2023 operating period and show that services are for the most part performing well, with expenses reporting at or below 20 to 30% of budget.

Many service's reports show them significantly under budget. This is expected, as many expenses are dependent on the time of year and the positive variances are not expected to hold up as the year progresses and planned work is undertaken.

While the results of the first quarter look favourable, readers are cautioned that results will vary significantly as the year progresses. Many services have expenses that are back-end loaded or do not occur on a regular schedule. While they have been budgeted for, they do not lend themselves to straight line forecasting based on the portion of calendar covered by the reporting period. One must also be aware that unbudgeted events do transpire that put pressure on budgets such as equipment failures and mechanical breakdowns. Similarly, recent changes to some expense items, subsequent to budget adoption, will negatively affect the services that the expenses arise out of.
