Background

The Bouchie-Milburn Neighbourhood Plan (BMNP) is a concept initiated by previous Area B Director Jerry Bruce, proposed as a trial project to conduct long-range planning by CRD staff, rather than contracted to a consulting team. The project was started in 2019, with numerous setbacks during plan development due to staff shortages, wildfire and flood emergency response, and the COVID-19 pandemic. However, the project team persevered and staff are excited to present the proposed final version of the Bouchie-Milburn Neighbourhood Plan for consideration of first reading. The plan is proposed to be appended to the Quesnel Fringe Area Official Community Plan (OCP). Plan Development

Development of the Bouchie-Milburn Neighbourhood Plan involved robust community engagement to ensure a document that reflects the desire of community residents. Direction and project oversight was provided by a dedicated project Steering Committee, comprised of area residents, Area B Director Barb Bachmeier, and some Area B Advisory Planning Committee members. Engagement included multiple neighbourhood mailouts, staff attendance at public engagement events, multiple community surveys, a project webpage housing all documentation, and an open house to present the final draft plan. The table below outlines plan development, engagement, and consultation timeline.

Lessons Learned

The staff-led project developed an informed, specific, and relevant plan; however, project scope and timeline was impacted and was continuously at significant risk of resourcing and capacity limitations outside control of staff. With a small planning department, there were no staff available to absorb resource needs or limitations during staff departures (both permanent and temporary) and during CRD Emergency Operations Centre support.

Overall, this was a hugely successful project. Staff are confident that this plan is and will remain reflective of the community's desires and needs for decades to come. It provides detailed, tangible guidance for future planning decisions at both the Board and staff level. It further provides strong policy backing and guidance for CRD advocacy regarding future decisions of other government agencies with jurisdiction in the plan area.

Proposed Recommendations

Recommendation #1 receives the report and deems consultation complete.

Recommendation #2 provides first reading of amending the Quesnel Fringe Area Official Community Plan, which, upon adoption will undertaking the following:

- Append the Bouchie-Milburn Neighbourhood Plan to the Quesnel Fringe Area OCP, giving the document the same weight and effect as an OCP.
- Provide the necessary policy and mapping updates to the Quesnel Fringe Area
 OCP to reflect the Bouchie-Milburn Neighbourhood Plan policies and direction.

Recommendation #3 confirms the Board has considered the Bouchie-Milburn Neighbourhood Plan in relation to the CRD five-year financial plan, and the solid waste management plan, in accordance with *Local Government Act* requirements.

Recommendations #4 and #5 give first reading to the necessary zoning and rural land use bylaw amendments, bringing a few properties into the Quesnel Fringe Area Zoning Bylaw to align with the proposed Bouchie-Milburn Neighbourhood Plan area boundaries.

Next Steps

- 1. Formal referral to Agricultural Land Commission as per Section 477(3)(b) of the *Local Government Act*.
- 2. Plan review and amendments, if required, based on ALC response.
- 3. Consideration of second reading by Board.
- 4. Schedule and hold public hearing.
- 5. Consideration of public hearing results, third reading and adoption.
