Recommendation

That the Central Cariboo Joint Committee receive this report for information; and further, that the Joint Committee forward a request for the overage amount in 2022 to be paid to the City of Williams Lake.

Purpose

To explain the details for the expenditures that exceed the budgeted amount in 2022 for the Cariboo Memorial Recreation Complex budget.

Background / Discussion

There are two outstanding activities that led to the increased expenditures in the 2022 Cariboo Memorial Recreation Complex Budget.

- 1. The projected revenues for the CMRC were affected negatively for two reasons. These amounts are listed in the next section of the report. This led to
 - a. The first three months of 2022 were still under the negative impact of the pandemic, and the restrictions on public recreation due to Provincial Health Restrictions.
 - b. Lack of available, trained Aquatic Staff to fulfill the demand of swim lessons
- 2. Unexpected expenses including chemicals, compressor repairs, ammonia leak and snow removal. Expenditures listed with over budgeted amounts below.
