# **Short Summary:**

Green Lake and Area Official Community Plan Amendment Bylaw No. 5408, 2022

## **Voting:**

### Memorandum:

This bylaw is being brought forward for consideration of second reading following the joint CRD/TNRD public information meeting held on May 6, 2023. Please see attached TNRD staff report for a summary of the public information meeting. Note that the CRD proposed amendments align with the TNRD amendments, with the exception of the proposed RV as a Temporary Use policy section. The CRD already has a region-wide Policy for consideration of Recreational Vehicles as a Temporary Use, and therefore would be redundant to insert into the CRD version of the Green Lake Area Official Community Plan.

The TNRD's amendment bylaw received second reading at their May 18, 2023, Board Meeting, and is scheduled for a public hearing and consideration of third reading and adoption at the TNRD's July 13, 2023, Board meeting.

Should second reading be received for the proposed CRD amendment bylaw, staff will arrange for a future public hearing on the CRD bylaw.
