Short Summary:

Destination Development Funds for Troll Mountain Resort

Voting:

Corporate Vote - Weighted

Memorandum:

In November 2022, the province announced the BC Destination Development Fund, a \$30 million-dollar provincial allocation for one-time grants to support continued recovery and resiliency of the tourism sector post pandemic. The two-stage application process required an expression of interest (EOI) with only shortlisted candidates required to submit a full application.

For this funding, municipalities and regional districts are in the unique position of being the only eligible applicant to apply for funding on behalf of mountain resorts.

Staff has been in contact with Mount Timothy and Troll Mountain Resort and EOI's were submitted for these partners as follows:

Proposed for Mount Timothy is additional accommodations and event hosting space with a request for \$985,000.

Proposed for Troll Mountain Resorts is the purchase and installation of a new lift to access an additional peak to increase their skiable terrain with a request for \$1,000,000.

On June 1st staff were contacted by the Ministry of Tourism, Arts, Culture, and Sport and invited to apply to stage two for the Troll Mountain Resort project.

If successful, the CRD will enter into a contribution agreement with the province and will enter into a second contribution agreement with Troll Mountain Resort.

Financial Implications:

The Destination Development program offers 100% funding towards eligible projects. There will be an administrative cost of staff time required for the Regional District to manage the mountain resort partnership agreement and serve as the payment certifier for the project as is expected by the province.

The proposed application is consistent with goals outlined in the 2023 North Cariboo Economic Development and North Cariboo Recreation and Parks Business Plans.
