# **Short Summary:**

Contribution Agreement with the Lakeview Cemetery Society in Roe Lake

## **Voting:**

#### Memorandum:

Cariboo Regional District staff received a request from the Lakeview Cemetery Society for support of operations at the Lakeview Cemetery (license #15177) on Roe Lake Crescent in Roe Lake; the Lakeview Cemetery is a certified cemetery and the Lakeview Cemetery Society is a registered society.

The Region has established a South Cariboo Cemeteries Services function through Bylaw No. 5071 (2017) to allow for contribution of funds toward the operation of established, registered cemeteries in the south Cariboo, including Electoral Areas G, H and L and the District of 100 Mile House. The Region currently has contribution agreements through the function with the District of 100 Mile House and the Forest Grove Cemetery Society.

The term of the proposed agreement would be three years (2023-2025) and would include a \$2,000 annual contribution to the Society.

## **Financial Implications:**

The agreement includes an annual contribution of \$2,000 from the South Cariboo Cemeteries Services function to the Lakeview Cemetery Society to support operations at the Lakeview Cemetery in Roe Lake. There is adequate funding in the 2023 budget to support the proposed agreement, but the long-term implications of the agreement may require an eventual requisition increase.

## **Policy Implications:**

The agreement is consistent with the intent of the South Cariboo Cemeteries Services function.
