BYLAW NO. 5447

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to amend the Wildwood Fire Protection Service Area.

WHEREAS a service area has been established by the Cariboo Regional District by Bylaw No. 2319, cited as "Wildwood Fire Protection Local Service Establishment Bylaw No. 2319, 1995", and amendments thereto;

AND WHEREAS pursuant to the provisions of the *Local Government Act,* being Chapter 323 of the Revised Statutes of British Columbia, and amendments thereto, a Board may, by bylaw, amend establishment bylaws;

AND WHEREAS the Board has been petitioned by owners of properties who wish to be part of the Wildwood Fire Protection Service Area;

AND WHEREAS the Manager of Corporate Services has certified the petition as sufficient and valid in accordance with the requirements of the *Local Government Act* and the *Community Charter*;

AND WHEREAS the Board has deemed it in the interest of providing good government to expand the boundaries of the Wildwood Fire Protection Service to include the petitioned properties;

NOW THEREFORE the Board of Directors of the Cariboo Regional District, duly assembled, hereby enacts as follows:

1. <u>Title</u>

This bylaw may be cited for all purposes as "Wildwood Fire Protection Service Area Amendment Bylaw No. 5447, 2023".
