At its April 14, 2023, meeting, the Board passed the following resolution:

2023-4-15

That the agenda item summary from Kevin Erickson, Chief Financial Officer, dated April 6, 2023, regarding financial implications of changes to Board Remuneration Amounts, be received. Further, that the EA Director annual base remuneration be increased to \$28,900, and that mileage and meal allowances be concurrent with federal rates as recommended by the Committee of the Whole, and the necessary bylaw be brought forward to the next meeting.

In accordance with the above, Bylaw No. 5436 was presented at the May 5, 2023 meeting and was adopted at that time.

Unfortunately, it has been discovered that Bylaw No. 5436 contained an error that needs to be rectified; it did not specify that the base remuneration increase was to be provided to the Electoral Area Directors rather than the entire Board. Bylaw No. 5451 is presented to accurately reflect the intentions of the Board when it passed resolution #2023-4-15.
