In 2022/2023 we supplied: 25 chemo quilts to the 100 Mile & District Hospital; 45 preemie quilts to Kamloops Inland Hospital; 10 lap quilts for Carefree Manor for residents use during bus trips; 5 wildlife and 6 landscape quilted wall hangings for Fischer Place palliative care rooms; 1 quilt donated to the Lone Butte Historical Society; 1 quilt donated to the upcoming 2023 Bridge Lake Fair for prize; 1 \$50 gift certificate from Dancing Quilts donated to the upcoming 2023 Bridge Lake Fair for Quilters Challenge prize; 46 dog beds using pillow cases filled with our fabric scraps dropped off at Lakeland Veterinary Clinic where they are picked up and taken to the Paws and Claws rescue shelter in Clearwater.


