The mission of the SCCEF is to support, promote, advance and encourage all community members of the South Cariboo. This is accomplished in the following ways:

- Education by establishing scholarship funds and providing funds for specific education endeavours
- Community Support by providing programs that directly benefit the needy and assist in alleviating human suffering and poverty
- Sports by encouraging amateur sports and recreation in our community
- Arts and Culture activities by supporting all forms of art and culture
- Preservation by promoting the preservation of lands and buildings or historical or environmental value as well as protection of the environment through hands-on projects as well as through courses and seminars directed at educating the public.
- Goals in 2023 involve more marketing, and development and strengthening of the administration and documentation of the foundation to add to our credibility and professionalism.

- 100 Mile Community Club \$8500 purchase and installation of industrial dishwasher
- Cariboo Chilcotin Partners for Literacy \$2500 Kindergym
- Timothy Lake Community Association \$15000 3-year project for a boat launch and picnic area for the public and emergency services
- 100 Mile House White Cane Association \$4500 to support annual services.
- Cariboo Pioneer Centre \$2500 to support programming. An additional \$2500 was provided by United Way to support COVID 19 projects
- Stemete7uy'i Friendship Centre (2019 and 2020) \$2,500 for First Nations programming and \$5000 to fund operational and COVID 19 costs
- Lone Butte Historical Association \$4500 to support operational and COVID 19 costs.
- Cariboo Family Enrichment Centre Gender Equality programming. \$5,000 An additional \$5,000 was provided by Community Foundations of Canada with whom SCCEF partnered as a matching grantor
- Stemete7uy'i Friendship Centre (2021 to 2023) \$30,000 for the project of relocating out of a church and on to Birch Avenue.
- Peter Skene Ogden bursaries of \$1,000 each for 2022 and 2023
- 100 Mile & District Historical Society \$5,000 for safety improvements
- Bridge Lake Fair \$2,500, supporting 2022 funding shortfall due to Covid
- Wranglers \$5,000 project to support increasing travel costs
- Quilts For Survivors \$2,500 to fund supplies for quilts for residential school survivors' project
- 100 Mile House Food Bank \$4,000 to fund their fresh produce project due to rising costs.
- Lone Butte Frozen Meal Program \$2,500 to fund increased food costs for volunteer frozen meal project for seniors
- 100 Mile & District Hospital Auxiliary \$2,500 to fund additional seating for emergency and laboratory patients.


The South Cariboo Community Enhancement Foundation has partnered with the Prince George Community Foundation, United Way Thompson Nicola and Community Foundations of Canada to bring \$62,500 funding to the South Cariboo. In 2018 we also received \$5,000 Federal funding which was awarded by us to:

- Cariboo Chilcotin Partners for Literacy \$2500 Story Walk Program
- Cariboo Family Enrichment Centre \$2,500 Relate Parenting Program (for parents of teenagers)

In 2023 the partnership with Prince George Community Foundation provided:

- \$15,000 to the Cariboo Family Enrichment Centre to update their technology, and
- \$32,000 to the Canadian Mental Health Association.

1. Brief Description of Proposed Use of Grant Being Applied For:

This project requests funding of \$1500 to cover marketing costs related to the operation of the South Cariboo Community Enhancement Foundation. The eight members of Board of the Foundation annually give an estimated 400 hours of their time to support the work of the Foundation. To establish a permanent presence in the South Cariboo, promote granting opportunities, develop partnerships and attract new endowments, and funding the SCCEF needs marketing resources including:

- Website subscription and ongoing updating and maintenance
- Advertisements
- Marketing Material
- Promotional events

The original agreement between the NDIT, DHM and CRD requires endowment returns to be limited to grants only, and we have no means to cover these marketing costs.

The grant for assistance will allow the SCCEF to encourage funding opportunities for organizations in the South Cariboo to contribute to the health and well being of our residents.

 How do you know there is a need for this service/project in our community? The South Cariboo requires an active and robust Foundation to help nonprofit organizations meet the needs of vulnerable individuals in the South Cariboo as well as to enhance recreational, cultural and community events.

The need for the South Cariboo Community Enhancement Foundation is evident by the number of organizations that have applied for funding and those that also apply for funding through the Grants for Assistance program. Community and non-profit organizations are still recovering from the COVID 19 epidemic which had reduced and eliminated many of their fundraising events.

3. Is your agency applying for funds from other levels of government or other sources for this project?

No. We have made inquires about how to fund the marketing and admin side of our responsibilities since we are unable to draw from the endowment returns. We have not had any success.

4. Would you still be able to complete the project if you do not receive the other funds applied for?

The SCCEF will be limited in its ability to promote and enhance funding opportunities for the South Cariboo if we do not have a source of marketing funds to support our work.


