BYLAW NO. 5461

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to amend the Central Cariboo Search and Rescue Service.

WHEREAS, a search and rescue service has been established by the Cariboo Regional District Board by Bylaw No. 3228, cited as “Central Cariboo Search and Rescue Local Service Establishment Bylaw No. 3228, 1996”;

AND WHEREAS, pursuant to the provisions of the *Local Government Act*, a Board may, by bylaw, authorize the revision of all or any of its bylaws;

AND WHEREAS the Board has deemed it desirable, and in the best interest of good government to amend the powers authorized in Bylaw No. 3228;

AND WHEREAS, pursuant to the provisions of the *Local Government Act*, this bylaw is authorized with the consent of at least 2/3rds of the service’s participants;

NOW THEREFORE, the Board of Directors of the Cariboo Regional District, duly assembled in an open meeting, enacts as follows:

1. CITATION

- a) This bylaw may be cited for all purposes as “Central Cariboo Search and Rescue Service Amendment Bylaw No. 5461, 2024”.

2. AMENDMENT

Section 2 of Bylaw No. 3228 is hereby deleted in its entirety and replaced with the following:

Powers

To operate this service, the Regional District may:

- (a) Acquire all such real property, easements, rights of way, licenses, rights or authorities as may be requisite or desirable for or in connection with the provision of the service;
- (b) Enter into such contracts with such persons as may be necessary or appropriate to establish and operate the service; and
- (c) Undertake and carry out, or cause to be undertaken and carried out, search and rescue and road rescue services in and for the said service area and do all things necessary or convenient in connection therewith including, without limiting the generality of the foregoing, establishing, training, and equipping a search and rescue squad and making provision for the appointment of such personnel to the squad as is considered necessary for the purpose of conducting searches and locating and rescuing victims.
