Board on the Road Meeting Policy Proposal

Memorandum:

The Board does not have a codified policy regarding its annual Board on the Road events, despite a well-established practice of conducting some of its meetings in locations away from the main office in Williams Lake. To promote consistency in how events are planned, organized, and held, and to establish roles and responsibilities, a policy on these events would be prudent.

Central tenets of this policy include:

- 1. Locations are determined by the Board Chair well in advance of the event occurring.
- 2. First Nations representatives are to be recognized and invited to Board on the Road meetings and events.
- 3. Directors are responsible for identifying planned activities outside of Board meetings on the road, i.e., any planned community tours or meetings with community groups.
- 4. The Communications Department remains responsible for coordinating and planning the Board on the Road event.
