TELUS Communications Tower – BC105335 – Chilanko Forks – Request for Concurrence Area J

Memorandum:

TELUS c/o SitePath Consulting Ltd. has completed a public consultation process, following Innovation, Science and Economic Development Canada's (ISED) Default Public Consultation Process. TELUS is requesting the concurrence be issued from the Cariboo Regional District for the TELUS tower proposal in an effort to provide improved TELUS wireless communications services in the Chilanko Forks area.

Staff note this proposal is located on Crown land, located north of Chilanko Forks, between Hwy 20 and Bendziny (Puntzi Lake). CRD Planning Staff have delegated authority to consider concurrence on Crown land telecommunications proposals, however have brought this proposal for Board consideration due to the varied nature of public feedback received.

TELUS staff note that this current proposal is an alternative site which was moved from Chilanko Forks due to negative public feedback. They assert there is not a viable alternative to the current proposed site to provide the necessary service coverage in the area that will meet federal/provincial funding requirements. Should the Board not provide concurrence, TELUS indicates they will likely abandon their efforts for servicing the immediate area.

- That the proposed tower is a permitted use;
- The proposed design and location is acceptable;
- That the Cariboo Regional District has been consulted and concurs with the tower location.
