# **Short Summary:**

UBCM Local Government Development Approvals Program 2024 Application

# **Voting:**

#### Memorandum:

The Cariboo Regional District (CRD) currently has three Zoning Bylaws and three Rural Land Use Bylaws which govern land use. The 2024 Planning Services business plan includes undertaking a consolidation project to result in a single zoning bylaw for the regional district. Staff note that policy sections of the RLUBs will be maintained until comprehensive Official Community Plan coverage is achieved. A further goal of the zoning bylaw consolidation project is to develop a comprehensive zoning map, as property zones are currently assigned and maintained via a database, rather than the common approach via mapping.

A common zoning bylaw and single zoning map across the region will provide consistency and clarity of use and interpretation by the general public and help in streamlining customer service. Staff anticipate a significant increase in efficiency and reduced risk for error for both responding to inquiries and processing planning applications. This project is at its initial stage, where staff are developing a workplan. We intend to make an application to the UBCM 2024 Local Government Development Approvals Program, up to the maximum program grant of \$150,000. This program is intended to support local government efforts in improving development application processes. It does not require matching funding from the CRD. The grant application deadline is March 8, 2024 and requires a Board resolution in support of the project.
