Subject: Bylaw Department Topics of Discussion

RECOMMENDATION

At the November 8, 2023 Budget Meeting the Board of Directors (BOD) expressed a desire to discuss the following bylaw topics in further detail.

- Communication,
- Resources, and
- Updating Bylaw Fees.

1. Communication

- a. Staff is working on standardizing communication between the Bylaw Department and the BOD. Attached to this report is a draft version of the Monthly Bylaw Stats Report that will soon be submitted to board meetings on a monthly basis.
- b. Some residents have expressed a lack of communication feedback from the Bylaw Department. The Bylaw Department is working on developing a Standard Operating Procedure (SOP) to create a complaint feedback system to bylaw complainants. It must be noted that the Bylaw Department has limitations on the amount and type of information that can be relayed to the public. The Bylaw Department is consulting with legal to ensure our public feedback system does not violate any privacy requirements.
- c. The public, at times, submit bylaw complaints directly to board members. When this occurs, the board members should direct complainant to file a formal bylaw complaint with the Bylaw Department.

2. Resources

a. The general consensus from the November 8 meeting was that more enforcement of CRD bylaws needs to occur. While the Bylaw Department agrees with this, staff resources are limited. Additional enforcement will require additional resources. Staff would like input from the BOD on the level of enforcement envisioned. Enforcement can be costly and lengthy depending on the level and type. If higher levels of enforcement are anticipated this will have to be addressed in the 2025 Bylaw Business Plan

Staff is tracking the workload of the current Bylaw Officer and propose to evaluate the need of an additional Bylaw Officer in the 2025 Bylaw Business Plan upon review of the 2024 workload summary.

3. Bylaw fees

a. Updating bylaw fees to be consistent with neighbouring municipalities and Regional Districts. Staff is actively comparing CRD Bylaw Offence Notices with neighbouring municipalities. Additionally, staff is comparing each department's bylaw offences as they relate to the CRD Bylaw Offence Notice Enforcement Bylaw No. 4886, 2014 for consistency.

EXECUTIVE SUMMARY

The above summary of items details staffs' attempt to address the concerns the BOD identified at the November 8, 2023 meeting. Staff requests input from the BOD on these topics to ensure BOD concerns are being addressed.
