#### **Background:**

This memo seeks to provide an overview of the activities in the Cariboo Regional District Emergency Operations Centre between May 2024 & September 2024

#### Wildfire 2024 (Task #24-1945)

The CRD Emergency Operations Centre was activated on March 26, 2024, in response to wildfire and stood down on August 22, 2024.

Total days of activation: 149 Active Alerts – 51 days Active Orders – 18 days

#### Wildfire Recovery

Recovery Operations were coordinated through the EOC for structural losses in the Barkerville area

#### **Next steps**

The CRD EOC has secured funding for After-Action Reviews (AARs) and plans to conduct both internal and inter-agency reviews, along with some one-on-one sessions where needed.

#### **Chilcotin River Landslide 2024 (Task #24-5170)**

The CRD EOC was already activated in response to fire when the Landslide event occurred. The response to the landslide in the EOC was between July 31, 2024 and August 30<sup>th</sup>.

# **Long-term incidents**

# Incident Monitoring (DGIR 220747\_No task #), Fuel Spill, EA A, March 2023, Monitoring Ongoing

CRD EOC is monitoring a reported fuel spill in Electoral Area A, with updates from the responsible party and assisting agencies. Ongoing.

## Spring Flood 2020 (Task # 210182), Landslide SOLE Maintenance, EA A, Monitoring Ongoing

SOLE remains in place for Electoral Area A and requires weekly renewals. Evacuation Orders due to landslide for properties in Electoral Area A remain in effect.
