# **Short Summary:**

Parkland Community Centre – Commission Request to Exit School Occupancy Licence

# **Voting:**

Corporate Weighted

#### Memorandum:

The Regional District received notice from the Parkland Recreation Commission in July 2024 advising that the group had resolved at its meeting May 1, 2024 that the Commission no longer wants to continue occupancy of a portion of the Parkland Elementary School to service as a local community centre.

The group intends to provide notice to School District 28 effective October 1, 2024 as per the required 90-day termination clause, which will end the agreement on December 31, 2024.

The occupancy agreement between School District 28, the Cariboo Regional District and the Parkland Recreation Commission was first executed in 2012 and includes use and occupancy of 21% of the school in return for a \$9,000 annual rental fee plus an estimated \$15,000 in utilities.

Despite the efforts of the Commission, regular use of the space as a community centre did not materialize and rentals and activities were limited.

The group now intends to re-focus its attention on development at the Kostas Cove property on Ten Mile Lake, which is held as a long-term recreation lease by the Regional District and managed by the Commission, with capital project support from facilities staff at the City of Quesnel.

#### **Financial Implications:**

The Parkland Recreation Commission has an annual allocation for operating and capital project costs within the North Cariboo Recreation and Parks (NCRP) financial plan. In 2024, \$44,282 was approved for operating costs and \$50,000 for capital projects.

Approximately \$25,000 per year of the operating budget is directly utilized for the community centre for rent and utilities and cancellation of the occupancy licence will result in savings to the NCRP budget.

The Commission is planning to increase ongoing maintenance and undertake numerous capital improvements at Kostas Cove as well as the connected trail system. The group will be submitting updated operating and capital project costs for consideration by the joint committee at its annual NCRP budget meeting in October.

# **Policy Implications:**

None. The licence was initially developed at the request of the Commission and confirming its cancellation is consistent with this approach.
