NDIT Application - 2025 Business Façade Improvement Program

Memorandum:

For the Board's consideration, please find attached an application to the Northern Development Initiative Trust (NDIT) from the Cariboo Regional District (CRD). The request is for \$20,000 in grant funding from the NDIT 2025 Business Façade Improvement Program.

This program provides annual grant funding of \$20,000 for local governments to enhance economic development by encouraging private sector investment in local business façade improvements. Eligible façade improvements include new lighting, architectural features, siding, painting, awnings, signage and accessibility improvements.

The Cariboo Regional District, with funding from NDIT, has offered this program since 2016. To date, 35 businesses have participated in the program. In 2024, four businesses participated in the program in Electoral Areas F, G, H and J. An attached document shows before and after photos of the South Point Resort in Canim Lake, highlighting the impact this program has on regional businesses.
