Project Information:

Brief description of proposed use of grant:

This grant will be used to help pay for rehearsal space, performance venues, and advertising for registration and concerts. We also use the funds to help pay for insurance premiums for our music library and general liability coverage.

How do you know there is a need for this project/event in your community?

Eclectica Community Choir has been a part of the 100 Mile House and area for over 20 years. The choir has performed at community events such as Remembrance Day ceremonies and July 1st celebrations. All our concerts continue to benefit local charities such at Fischer Place/Mill Site Lodge, the 100 Mile Hospital, the 100 Mile Food Bank, and Loaves and Fishes. Each fall, we have approximately 40 people from all over the Cariboo Regional District and the District of 100 Mile house.

Describe the key activities and timelines to complete the project

This season, Eclectica hopes to participate in all the activities we have done in the past as well as some new activities. In chronological order:

- 1. Remembrance Day service Nov. 11
- 2. Singing at Fischer Place/Mill Site Lodge and Carefree Manor Nov. 11
- 3. Canadian Composers Recital Nov. 23
- 4. Christmas Concert Dec. 15, 2024 all proceeds will go to 100 Mile Food Bank and Loaves and Fishes
- 5. March 2025 we are hoping to host a Parade of Choirs with all proceeds going to a local charity.
- 6. April 2025 Participate in 100 Mile Festival of the Arts
- 7. May 2025 Spring Concert proceeds to go to 100 Mile Hospital Auxiliary and Fischer Place/Mill Site Lodge Auxiliary

How will you determine if the project/event is successful?

The success of the choir is based on how many people come back to choir each season and how many people attend our events, generating donations to local charities. Even after closing down for three years, the choir has between 40 and 50 people registering each term. We continue to generate approximately \$3000.00 for local charities.

Does your organization have sustainable funding? Please explain.

Our choir collects \$35 per term from each member. This registration fee is used to cover the cost of rehearsal space, venue rental, insurance, advertising, and memberships in local and provincial arts organizations. In the past, registration fees and grants from the Cariboo Regional District and the District of 100 Mile House have allowed us to accumulate small surpluses that we have used to purchase new music. Since the pandemic shut down where we continued to pay insurance premiums, we have used all of our funds. Grant assistance is still necessary to cover the basic costs of the choir.

Is your organization applying for funds from other sources for this project/event? If yes, what other organization(s)? How much? \$2000.00

We recently received a grant from the South Cariboo Community Enhancement Foundation that will go towards purchasing new music, training more conductors, and hosting workshops for choir members. This is an exciting opportunity to grow the resilience of the choir and support our members' musical abilities. Because of financial restraints we have been unable to do any of these activities for the past four years.

Describe the impact of this application being denied or approval of an amount less than requested. Will you be able to complete the project/event if you do not receive the funding requested?

The planning team has worked very hard to get the choir up and running again. Members of the planning team have paid for much of the advertising and concert venue rentals for the past two year so we could continue but these donations are not guaranteed going forward. With the this grant from the Cariboo Regional District and the District of 100 Mile House, we are becoming more sustainable. Without this grant or with a lesser amount, the choir will continue but we will have to spend more of our development funds to cover the running of the choir, thereby reducing the amount we have for music and workshops.

Does your organization charge user fees/membership/admission? If yes, please explain or attach your current fee structure.

We charge \$35.00 per term and we have a fall term (Sept.-Dec) and a spring term (Jan-May). We do not charge admission to our concerts but have concerts with admission by donation to local charities. If we charged admission, we would have to pay substantially more for copyright on the music we perform. We are also deeply committed to giving back to our community.



Last season, we covered our cost primarily through registration fees. We received a combined \$1000.00 grant from the District of 100 Mile House and the Cariboo Regional District. We also receive \$100 from the committee organizing the July 1st celebrations at the 108 Heritage Site.

Proposed Use of Grant

- 2. Rental of Martin Exeter Hall for Christmas and Spring concerts approximately \$850.00
- 3. Insurance Axis \$450.00

Re: Report on Previous Grant for Assistance

On behalf of Eclectica Community Choir, I would like to thank both the District of 100 Mile and the Cariboo Regional District for your Grant for Assistance for the 2023-2024 choir season. The \$1000.00 provided helped Eclectica helped us cover essential costs and build the choir's resilience. The money the Districts provided us last season helped cover the costs of rehearsal space, music performance fees, insurance, and membership in the BC Choral Federation and 100 Mile Arts Council.

We continue to be a wholly volunteer organization dedicated to bringing a choir and choral music to 100 Mile and the surrounding areas. Last season, we had 43 singers from 100 Mile and all over the Cariboo Regional District. Most of these people have returned to choir this fall and have encouraged new members to join. We believe this speaks clearly to the success of the choir.

In the fall term, we performed at the community Remembrance Day service run by the The Royal Canadian Legion on November 11, 2023. We also had a successful Christmas Concert at Martin Exeter Hall where the audience donated almost \$2000.00 to the 100 Mile Food Bank and Loaves and Fishes.

In the second term, we participated in the 100 Mile Festival of the Arts, giving the choir an opportunity to be adjudicated by a skilled expert, helping to build our skills. In May, our spring concert raised money for the Hospital Auxiliaries here in 100 Mile. At our spring concert, we acknowledged both the District of 100 Mile and the Cariboo Regional District for their ongoing financial support both in announcements and in our concert program. After our regular season, a small group from the choir sang at the July 1 celebrations at the 108 Heritage Site. We continue to look for ways to benefit our communities.

We received a final memorial donation to cover most of the hall rental last season so we were again able to donate all proceeds from our concerts to local charities. A member of the choir also paid for the newspaper advertising for choir start up and concerts. We did not have funds to purchase new music or provide workshops or training for our members but have secured funds to work on this in this season. The CRD and District of 100 Mile's financial support, we will be able to keep making music and give back to our community.
