Frozen meals grant received from Legion, South Cariboo Community enhancement foundation and Better at Home.

Christmas Hamper:

Organized by Susan, we handed out hampers. Donations exceeded the cost, funds moved to emergency fund.

Frozen Meal:

On going. Added Better at Home as another distributor. Over meals served

Old Business:

- 1.Pickle ball courts completed. Asphalt, resurfacing fundraiser, hall support and grant money all raised to complete in 2024
- 2. Fence completed at courts, want to move driveway fence in closer to create extra parking.
- 3. Furnace: 2 new furnaces installed
- 4. Solar panels: Completed in August 2023, Hydro still has not credited our account

New Business:

- 1.Air Conditioner: Board would like to move forward with A/C install summer 2024
- 2.Outdoor covered area: plan is to build a covered picnic area by pickle ball area
- 3. Propane sensor: peace of mind to install new kitchen propane leak monitor
- 4. Faucet lock box: Jayco to install lock covers for outdoor faucets

Election of Officers:

Executive positions that need to be filled: President, Vice President and Treasurer for a 2 year term. Gary, Theresa and Mai agree to be nominated for another 2 years.

Nominations open for President: Dolores put forward to elect Theresa Draper for President. Pat Lytton reads 3 times Theresa Draper for President. Theresa accepts and all approved.
