# Voting:

## Memorandum:

The 2025 Five Year Financial Plan is presented to the Committee for a final review before going to the Board at the March 21st, 2025, meeting for three readings and adoption.

Since the January 23rd, 2025 meeting, one change was made and is reflected in the attached reports.

The aforementioned change is a reduction to the operational budget of the Interlakes Volunteer Fire Department. Reductions were made to the Training, Hoses and Couplings, and Building Repairs and Maintenance allocations to allow for a 2% reduction in the current year's tax requisition.

The overall budget is now \$78,878,841, down from the \$78,888,444 as reported in the January 23rd, 2025 Finance/Budget meeting. The tax requisition is now \$35,394,591, a reduction of \$9,603 from the \$35,404,194 presented in January.

Barring any further amendments, the attached Detailed Five-Year Plan and supporting schedules, comprise the CRD 2025 – 2029 Five-year Financial Plan to be presented to the Board at the March 21<sup>st</sup> meeting.
