Committee members discussed an action plan towards AAP implementation.

6.1.1 Shivani discussed that ADAC must provide feedback on what priorities need to be focused on for next year 2025. At least 2 to 3 priorities need to be made.

Members discussed multiple items as priorities:

- Agricultural Education in the class rooms were brought up. Discussion on a support letter from CRD would be beneficial to send to school districts.
- Water licensing charges and rebates- Becoming too much paperwork
- Implementation on prioritized strategies on page 26
- Expectation that CRD would make a report and bring back to ADAC with recommendations on which priorities ADAC could work on for 2025

- Economics with agriculture
- ALR- Developing strategies for Agriculture and NON agriculture land
- Being more collaborative with Ministry of Agriculture
- Meat Processing – Abattoirs
- Avian flu was brought up as an issue but not currently in the APP plan – CRD notes that it was missed however a document will be shared to members to look over
- Climate Change
- Wildlife Management

9.2 David Z. mentions that the Cariboo Cattlemen’s association are working on a strategic plan focusing on lots and cost of production. They have currently 26 business models that they are looking at. Working on what practices work best for farmers.

9.3 Tammy B. mentions things are currently quiet in horticulture, seasonal greenhouses are closing down this time of year.

9.4 Robin H. states that the food hub is finishing up. Advertising/Marketing will be happening in November.

9.5 Jenn R. updates with the Quesnel Cattlemen’s association AGM is Nov 23rd, they are looking to build their membership. Cattle pricing will be strong this year during sales. Mentions that there is a program going to be starting called the Burger it forward program Feb 2025. This will be sales of beef in restaurants and all sales will contribute to the food banks. 9.6 Tyrone J. mentions final round ups are happening. He is meeting with local ranchers. Shared there is a video from the Cattlemen’s association about fencing to keep range cattle
