NCLGA Resolution - Mental Health Supports for Elected Officials

Memorandum:

The Board directed staff at its January 24, 2025 meeting to conduct background research and prepare for this topic. The resolution being recommended was supplied by the Islands Trust and is in the process of being endorsed for the Association of Vancouver Island and Coastal Communities (AVICC) convention.

A search of the UBCM's resolutions database did not identify any existing policy on this subject matter. Barring intervention of the UBCM Executive, the most likely recommendation from the UBCM Resolutions Committee at convention will be "No Recommendation".

The Board may wish to consider refraining from making a submission, considering that this resolution is effectively a duplicate of the Islands Trust's. While endorsement at the NCLGA convention will increase the number of organizations advocating for the proposal, it does not impact the resolutions process at the UBCM Convention.
