NDIT Application - Nazko Valley Community Centre Society - Room Renovations

Memorandum:

For the Cariboo Regional District Board's consideration, please find attached an application to Northern Development Initiative Trust (NDIT) from the Nazko Valley Community Centre Society. The request is for \$30,000 to assist with renovation costs for an unfinished room in the community centre. The unfinished room is in the Nazko school building but is a separate building space currently not in use. This area will be converted into a multipurpose room used for community programming and events. Renovations include flooring, walls, HVAC and furnishings.

Funding support for this project, which has a total value of \$62,900, is anticipated to come from Northern Development (\$30,000), Quesnel Community Foundation (\$25,000) and the Society (\$7,900). Funds needed to complete the renovations will come from fundraising and donations.

Prior to forwarding the application to NDIT for the Regional Advisory Committee's consideration, all Regional Development Account applications require a resolution of support from the local government within the jurisdiction.
