#### Memorandum:

For the Cariboo Regional District Board's consideration, please find attached an application to the Northern Development Initiative Trust (NDIT) from the Williams Lake Cycling Club, for \$2,500 to assist with costs for their 2<sup>nd</sup> Annual Ride Your Ride Women's Mountain Bike Festival.

Funding support for this project, which has a total value of \$24,400, is anticipated to come from Northern Development (\$2,500), Gibraltar Ltd (\$2,000); Mount Polley (\$1,500); Enbridge (\$2,000), West Fraser (\$500), Tolko (\$500), City of Williams Lake (\$1,000), Cariboo Regional District (\$1,000), registration fees (\$9,600) and fundraising (\$3,800).

Prior to forwarding the application to NDIT for the Regional Advisory Committee's consideration, all Regional Development Account applications require a resolution of support from the local government within the jurisdiction.
