2. <u>ADOPTION OF SPECIAL OPEN AGENDA</u>

3. SPECIAL MEETING BUSINESS: Meeting with School District #28

3.1 NCJAC Discussion Items:

- a. Provincial lobbying:
 - I. Ministry of Transportation and Infrastructure (MoTI): Barkerville Highway school speed zone at Barlow Creek Elementary
 - Director Massier provided an update. After years of lobbying for school zone speed limits, the Ministry has acknowledged that there is potential for change. There is a traffic report John is hoping to acquire.
 - A speed-reader may help deter excessive speed

Actions that MoTI suggested be undertaken prior to next school season:

- East toward the City Cut and thin the trees on the property approaching Barlow Creek Elementary, to improve sightlines.
- Property adjacent to school heading away from City Contact private property owner to discuss same mitigation (fire smart).

II. CNC/UNBC – future programming

Discussion included:

- The college is struggling financially with the reduction in International Student permits and has been looking at regionalizing to Prince George, affecting the local campus programming.
- Advocate for student housing

- A private sector Committee to lobby for improved utilization of our local campus, as the current Committee is mainly comprised of CNC/UNBC staff; not conducive to increasing/reestablishing local programs.
- b. Organizational information updates:
 - I. Plans when the new Carson Elementary School opens
 - The School District advised a catchment review is in progress, looking at all routes. Community engagement will follow.
 - The existing Carson Elementary located on Graham Avenue will be demolished once the new school is operational.
 - II. General safety in school zones
 - Concerns raised by the Committee regarding bus turns off Highway 97N and issues on Maple Drive will be taken back to the Board for discussion.
- c. Indigenous education options; current status and anything in progress by School District and/or other entities.
 - The School District advised they weren't able to discuss at present.

3.2 School District #28 Discussion Items:

- a. Requested an update on city/community developments and potential impacts to schools and enrollment
 - Councillor Roodenburg noted the following:
 - Roddis Drive Assisted Living potentially 300 workers + families
 - o New residential builds in South Quesnel, Downtown Quesnel
 - New hotel; South Quesnel
 - School District #28 noted this type of information has value in determining developments that may affect area population that could assist in planning for school attendance. Note: housing developments often only redirect the population versus adding the number of students.
 - Is there a process for the School District to be updated on approved new developments that may affect population density/change.
