In addition to Grants for Assistance approved through the main intake process, the Cariboo Regional District also provides, through a year round intake, a limited amount of Grants For Assistance, for applications of \$1,000 and under, to local non-profit organizations for projects, activities and events that strengthen and enhance the wellbeing of the community, promote volunteerism and support the goals and priorities of the Cariboo Regional District.

The Year Round Intake program is intended to assist organizations under unforeseen or time sensitive circumstances which preclude an application to the Annual Intake program.

Applications may be submitted to the Cariboo Regional District via mail or hand delivered to the Williams Lake office Suite D, 180 North Third Ave., Williams Lake, BC V2G 2A4; facsimile at 250-392-2812; or email at mailbox@cariboord.ca. Applications may also be hand delivered to the Quesnel office 102-410 Kinchant Street, Quesnel, or the 100 Mile House office #3-170 Cedar Avenue, 100 Mile House.

Before submitting your application, please ensure you have included all required documentation: (incomplete applications will not be considered):

- Completed and signed application form
- Required report for previous Grant for Assistance (if applicable and not already submitted – if unsure, please contact us). The report should contain the following information:
 - How the funds were utilized;
 - The success of the project or event;
 - The benefits of the project or event; and
 - The manner in which the CRD was publicly recognized for providing funding.
