

CARIBOO REGIONAL DISTRICT

BYLAW NO. 5502

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to establish user fees for Cariboo Regional District sewer systems.

The Board of Directors of the Cariboo Regional District, duly assembled in open meeting, hereby enacts as follows:

1. <u>Title</u>

This Bylaw shall be cited for all purposes as the "Cariboo Regional District Sewer Rates Bylaw No. 5502, 2025".

- 2. <u>Rates</u>
 - A) There is hereby imposed and levied each year a sewer user rate, as set out in Schedule "A" attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Lac La Hache sewer system as per the terms and regulations set forth within "Lac La Hache Specified Area Sewer Management Bylaw No. 1905, 1986", and any amendments thereto.
 - B) There is hereby imposed and levied each year a sewer user rate, as set out in Schedule "B" attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Pine Valley sewer system as per the terms and regulations set forth within "Pine Valley Specified Area Sewer Management Bylaw No. 1806, 1985", and any amendments thereto.
 - C) There is hereby imposed and levied each year a sewer user rate, as set out in Schedule "C" attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Wildwood sewer system as per the terms and regulations set forth within "Wildwood Specified Area Sewer Management Bylaw No. 2141, 1987", and any amendments thereto.

- D) There is hereby imposed and levied each year a sewer user rate, as set out in Schedule "D" attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Alexis Creek sewer system as per the terms and regulations set forth within "Alexis Creek Specified Area Sewer Management Bylaw No. 2240, 1988", and any amendments thereto.
- E) There is hereby imposed and levied each year a sewer user rate, as set out in Schedule "E" attached to and forming part of this bylaw, against the owner or occupier of real property connected to the Red Bluff/Dragon Lake sewer system as per the terms and regulations set forth within "Red Bluff/Dragon Lake Sewer Management Bylaw No. 5059, 2016", and any amendments thereto.

3. <u>Repeal</u>

"Cariboo Regional District Sewer Rates Bylaw No. 5473, 2024" and all amendments thereto are hereby repealed.
