Asset Management Strategy

Memorandum:

Staff contracted PSD CityWide to conduct a review of the CRD's current Asset Management Policy and practices, and to formulate a strategy to outline a pathway towards an Asset Management Plan. This project is supported by a UBCM Asset Management grant of \$15,000. The Strategy has undergone multiple refinements and reviews by staff.

The proposed strategy outlines a three-year timeline for implementing recommended practices for asset management, culminating in the development of an Asset Management Plan at the end of 2027. There are a few risks to achieving the objectives:

- 1. Staff capacity asset management responsibilities are spread throughout multiple positions and departments.
- Inter-departmental coordination current approaches are ad hoc and not managed in a consistent manner.
- 3. Financial the initiatives outlined in the strategy carry moderate risks to the budget in terms of increased expenditure potential (staff, consultants, software, training, etc.).
