#### **Short Summary:**

150 Mile House Fire Protection – Fire Apparatus Assent Vote & Firehall Replacement Assent Vote

#### **Memorandum:**

The 150 Mile House Volunteer Fire Department needs a new fire engine apparatus to replace a unit that is aging out. In addition, their firehall is in need of significant repairs, which will be less cost effective than constructing a new firehall.

The Area Director has discussed the situation with staff, and this item is presented for the Board's approval to proceed with an assent vote (referendum) for a new fire engine apparatus and firehall.

The loan authorization and service amendment bylaws are presented on today's agenda for consideration of three readings, and the next steps in proceeding to assent voting may be taken as outlined in the recommendations below.
